RULES OF THE COMPETITION:

1. The candidate must be 35 years of age or younger on the day that entries for the competition closes.
2. The enterprise must be a registered entity and in full operation for a minimum of 12 Months; in the event of the enterprise/entity, it must be owned by young people 100%.
3. The candidate's business/farm must be within Vhembe District.
4. The candidate must be a South African citizen.
5. The competition is open for all Agricultural commodities.
6. Candidates who have participated and won in this competition previously are not allowed to re-enter this competition again (i.e. getting either position 1, 2 & 3).
7. A panel of judges will visit all finalists/shortlisted candidates in their Enterprises/farms
8. The decision of the panel of judges will always be final.
9. Winners must be prepared to be photographed.
10. Participants should be operating in the following Agricultural minimum scales
 - 10.1 Crop production – 1ha and above
 - 10.2 Broiler production – 500 chicks per batch and above
 - 10.3 Large Stock (Cattle production) – 20 heads of cattle and above
 - 10.4 Small Stock (Goats/Sheep Production) – 50 heads of Goats/Sheep and Above
11. Closing date for the entry forms is the **19 May 2023. @ 16h00**
12. Entry forms can be collected from all Local Municipality LED Offices i.e. Thulamela, Collins Chabane, Musina, Makhado, Vhembe Municipality LED offices, Department of Agriculture Offices, NYDA office in Thohoyandou and SEDA Vhembe Office.
13. The completed Entry forms must be **SUBMITTED/RE-TURNED TO THE REGISTRY OFFICE OF VHEMBE DISTRICT OFFICE IN THOHOYANDOU ONLY** and no form will be received after the due date.
