SCOPE OF WORK FOR SERVICES REQUIRED

The scope of work is to provide guidance to the service provider on the services required to the provision of support and maintenance for the municipality. The service provider will supply ICT services on an as-and-when required basis to the Vhembe District Municipality. The service provider will also maintain the software licenses of the municipality ensuring compliance with OEM requirements for use of all the relevant software. 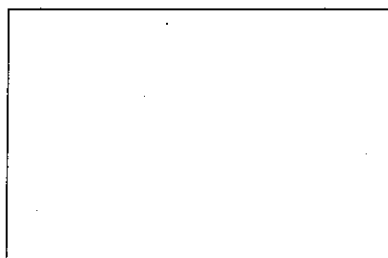

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
